## GDPR – UE 2016/679 - PRIVACY ADVICE

### 1 Subject

In accordance with art. 13 of D. ### 6 Transfer of personal data

### **10 Rights of the person concerned**

At any time, you may exercise, under art. 7 of Legislative Decree 196/2003 and Articles 15 to 22 of regulation (EU) No 2016/679, the right to:

- a) Seek confirmation of the existence or otherwise of personal data;
- b) Obtain the particulars of the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, where possible, the retention period;
- c) Obtain the correction and cancellation (right to oblivion) of the data;
- d) Obtain the limitation of maintenance/treatment;
- e) Obtain the portability of the data, i.e. receive it from a holder of the treatment, in a structured format, commonly used and readable by automatic device, and transmit them to another holder of the treatment without impediments;
- f) Oppose treatment at any time;
- g) Revoke the consent at any time without prejudice to the lawfulness of the treatment based on the consent
